श्री सतपाल सिंह रायजादा (ऊना) द्वारा पूछे गए अतारांकित प्रश्न संख्या 2051 से सम्बन्धित उत्तर:—

- (क) मण्डलायुक्त न्यायालय, कांगड़ा में जिला ऊना से सम्बन्धित कुल 1421 मामले विचाराधीन थे। गत तीन वर्षों में दिनांक 01.02.2022 तक मण्डलायुक्त कांगड़ा द्वारा जिला ऊना के 25 दौरे किए गए। इस दौरान कुल 1326 मामलों में सुनवाई की गई व 95 मामलों में कोई सुनवाई नहीं हो पाई। इन दौरों के दौरान कुल 54 मामलों में फैसलें सुनाये गए व हल किये गये। वर्तमान में मण्डलायुक्त न्यायालय कांगड़ा में जिला ऊना से सम्बन्धित कुल 1367 मामलें निर्णय हेतु लंबित है।
