NOTIFICATION

The Himachal Pradesh Vidhan Sabha Secretariat, Shimla-4 today declared the final result for recruitment to two posts of Driver advertised vide advertisement No. VS/Estt./Advertisement /6-13/2017-II, dated 07th December, 2021. The detail of online applications received, applications found in order/approved and candidates who appeared for written examination is as under: -

The written test for recruitment to two posts of Driver was held on 14.05.2022 and candidates were shortlisted for driving test in the ratio of 1:10 as per merit of the written examination. Thus, the 1st 20 candidates were called for driving test on 27-06-2022 at HRTC Workshop, Taradevi, Shimla-10. The committee submitted the result of driving test held on 27-06-2022 to this Secretariat. On perusal of the result, it was found that none of the candidates declared qualified in the driving test. This matter was placed before the Hon'ble Speaker for his kind consideration and after detailed deliberation in the matter it was decided that candidates for driving test may be called in the ratio of 1:20. Therefore, the 1st 40 candidates as per merit of the written examination were called for driving test on 19-07-2022 at ITBP Link Road, Taradevi, Shimla-10. The driving test was held on 19-07-2022 on vehicle No. HP07D-0270(Mahindra Bolero) for Light Motor Vehicle and HP07A-0718(Bus) for Heavy Vehicle under the supervision of the Committee constituted in this regard and Committee submitted the result of candidates appeared for driving test. As per result submitted by the Committee, 14 candidates were declared qualified/passed.

The candidates who qualified the driving test were called for evaluation of documents on 08-08-2022 and on the basis of documents produced by the candidates and physically verified by the Committee on 08-08-2022, the marks were allotted in accordance with instructions contained in Department of Personnel, Govt. of H.P. letter No. Per(AP-B)B(15)-5/2014, dated 17-04-2017.

After completion of entire process of written examination, driving test and evaluation of original documents, the following candidates have been declared successful for recruitment to two posts of Driver:-
